NOTICE OF RIGHT TO CANCEL TO A CLIENT/CUSTOMER WHO IS A CONSUMER WITH A RIGHT OF CANCELLATION UNDER THE CONSUMER CONTRACTS REGULATIONS AS SET OUT BELOW

This notice is provided to persons who have entered into a contract to which the Consumer Contracts (Information, Cancellation and Additional Charges) 2013 ('the Regulations') apply. The contract is for the provision to you of building services.

Under the Regulations, you have the right to cancel this contract if you wish to do so. This Notice explains how to exercise this right. It also gives you other information which is required by the Regulations.

In order to exercise your right to cancel the contract, you need to deliver or send a cancellation notice, that is, a written notice that you wish to cancel the contract. You can use the Cancellation Notice provided below if you wish, but you do not have to do so. You can send your notification by e-mail if you prefer to info@kovacsconstruction.co.uk

Any cancellation notice should be delivered or sent to the contact details below. To meet the cancellation deadline, it is sufficient for you to send the notice before the cancellation period has expired.

You have 14 days in which to serve a cancellation notice. The period of 14 days begins on the date when you accept our quotation. The 14-day period is referred to in the Regulations as 'the cancellation period'.

Under the Regulations the cancellation notice is treated as being served as soon as it is sent or posted to us and a cancellation notice sent by electronic communication is treated as being served on the day when it is sent.

If you agree in writing that the performance of this contract should begin before the end of the cancellation period, then, even if you cancel the contract, you may still be required to pay for the goods and services supplied before the cancellation. However, should you have paid any monies on account; we will reimburse any monies already paid by you within 14 days of receiving your notice to cancel this contract. We will reimburse you by the same method we received payment unless agreed otherwise; in any event you will not incur any fees as a result of this reimbursement.
